



Thank you for hosting a NFTYx event and strengthening the Reform Youth Movement across North America!

To create your NFTYx event registration:

1. **Registration Site:** You can create your registration in any platform that you would like. [Wufoo](#) is a common platform that you can also set up to take [payments](#) if you are charging for the event. You can also use your congregation's registration platform, or any other platform, that is easy for your community.

NOTE – We are excited to share that by Fall 2023 we will have the option of housing registration on a URJ platform. More to come!

2. **Data to Ask For: At a minimum, please ask for the information in the “required registration information” listed below.** This is the information you will send to the URJ following your event so that we can upload the teens into our database and invite them to the next NFTY event in your region.

While the URJ does not collect this information, we also suggest the following questions based on the event content:

- a. Parent/Guardian cell number (emergency contacts)
 - b. Medical information (allergies, issues we should be aware of...)
 - c. Dietary restrictions
 - d. grade
 - e. Housing information including gender/preferred housing (if an overnight event)
